Clinic Confirmed Baby Survived Abortion, Offered to Kill Her Again. Her Mom Refused: "God Preserved Her"

hen "Lisa," a 25-year-old woman, called Crossroads Care Center in Auburn Hills, Michigan, in the fall of 2015, she felt like she was out of time, out of options, and destined to endure the remaining stages of an abortion she already regretted.

A week earlier at a nearby abortion business, Lisa had ingested mifepristone-the first of two pills in the chemical "abortion pill" regimen, meant to end the life of her preborn child. She had even taken the second pill in the regimen (misoprostol) to induce labor, but the contractions never came.

Lisa felt something was going drastically wrong.

In a follow-up appointment at the abortion

business, Lisa told the clinic staff about her symptoms, and they confirmed via ultrasound that the chemical abortion had failed and her baby was still alive.

From there, abortion workers gave Lisa two "options": they could finish the abortion via surgery or make another attempt at a chemical abortion.

"She chose neither of those," Tracey Fish, a physician assistant who works with Crossroads Care Center, said. "She wanted to keep her child, but they didn't offer her that option. So, she called us, wondering if we could help her."

Calling during off-hours, Lisa—who'd been to Crossroads while she was still trying to decide whether or not to keep her baby—reached Tim Stickel, the center's executive director, who happened to be in the office.

Crossroads then connected Lisa with a high-risk ob-gyn for emergency treatment, and for care during the rest of her pregnancy. In the meantime, Stickel, Fish and others spent precious hours in prayer, mentorship and biblical counseling with Lisa and the father of her baby—both during and after pregnancy.

In the spring of 2016, Lisa gave birth to a healthy baby girl.

"It was God who preserved her," Stickel said. "We've never cried more and prayed more for somebody. It was an emotional roller coaster. There was a huge time investment, but it was only after God had done His work of preserving this child."

As Stickel and his team at Crossroads—which serves over 200 clients each month—watched Lisa change her mind and successfully rescue her baby from an in-progress abortion, they began exploring new ways to help women like her.

Starting this March, Crossroads is joining the Abortion Pill Reversal Network—over 350 medical providers that are equipped to rescue babies from abortion with the Abortion Pill Reversal protocol.

Well over 400 mothers have successfully rescued their babies through Abortion Pill Reversal since 2007, when two doctors pioneered the life-saving treatment—an emergency injection and follow-up schedule of progesterone treatments that have been used to prevent miscarriage since the 1950s. For Stickel, as well as Fish, the decision to join the network has been an easy one, especially after watching Lisa rescue her child.

"We want to open up opportunities for women to have options if they change their mind," Fish said. Note: Gayle Irwin writes for PregnancyHelpNews.

Meet Giselle, the Latest Baby Rescued by Abortion Pill Reversal



By the time Giselle entered the world in early December, she arrived fully equipped with her own protective detail of three older brothers. They're old enough to know their sister is a precious addition to their family, but they're years away from understanding just how priceless she is.

What Giselle's brothers will learn in time was that their mother, Samantha, was left high and dry by Giselle's father and turned to a chemical abortion pill as what she felt was her only way forward.

Then, almost as soon as Samantha had taken the first of two chemical abortion pills—which ends a baby's life in utero ahead of the second and final pill, inducing labor—she changed her mind and reached out to the Abortion Pill Reversal hotline (1-877-558-0333) for help.

Through the hotline, Samantha was connected to one of 350 providers in the nationwide Abortion Pill Reversal network trained in a life-saving protocol that starts with an emergency injection of progesterone used since the 1950s to prevent miscarriages.

Samantha's daughter, Giselle, was born December 1, 2017—an event celebrated all month by Abundant Hope Pregnancy Resource Center in Attleboro, Massachusetts, where Samantha had learned about the life-saving option before going in for her abortion appointment.

"For those who have been following along with the story of Sam, and the miracle of Abortion Pill Reversal, we are so excited to introduce her little girl, Giselle," the pregnancy center posted in early December. "Born Friday, December 1st at 2:00 p.m. 6 lb 3oz, 18-3/4 in. Both mom and baby are in perfect health and doing wonderfully. And her three older brothers are completely smitten with their new sister. Please send this beautiful family prayers as they begin their journey with a new bundle of joy!"

Protocol for Abortion Pill Reversal

Dr. George Delgado, MD, FAAFP established a protocol for the use of progesterone as an inhibitor of the effects of mifepristone, to be used when a woman changes her mind about a medical abortion that has been started.

Delgado reports that as of December 2014, the method used by him and his associates has a 57% success rate. Of the 223 women who have used his method, 157 succeed in carrying their children to term, are awaiting delivery or were those "lost to contact" after 20 weeks in the study.

The fact sheet noted that all of the babies were "normal at birth."

Frequently Asked Questions What Do I Need To Do?

Call our hotline: **877-558-0333.** Our on-call nurse will ask you some basic questions to see if reversal is possible. The nurse will then connect you with a doctor or medical provider in your area to start treatment, if that is your choice.

What Is the Treatment to Reverse Abortion Pill?

An ultrasound will be done as soon as possible to confirm if your baby is still alive. The doctor or other medical provider will prescribe progesterone, which will be given by injection in the gluteus ("butt") muscle, by mouth or by vagina. The treatment will continue through your 1st trimester of pregnancy.

APR Foundational Principles Abortionpillreversal.com

1) It is reasonable and appropriate to respect a woman's right to choose to reverse a medical induced abortion.

2) A woman should never be coerced into starting or continuing an abortion.

3) Human beings are valuable and should be protected at all stages of their development.

4) Mifepristone does not significantly increase the chances of birth defects. Reversing a mifepristone medical abortion is within reasonable medical practice.

5) Progesterone has been safely used in pregnancy for over 40 years.
